On December 29th, 2012 at approximately 10:02PM, Pine Hill Officers assigned to a directed foot patrol in the Mansion's Apartments, located at 220 West Branch Avenue approached a male and female in the area of the 1500 building involved in a suspected narcotics transaction. As the officers approached, the male, identified as Louis Tiller, fled the scene towards the 1500 building. Officers detained the operator of the vehicle, Bethany Kerr and determined she was loitering in the complex to obtain CDS. The female was arrested for possession of a schedule II narcotic and loitering to obtain CDS.

Continued investigation led the Officers to the residence of Louis Tiller. Investigation at the apartment led to the seizure of a plastic bag containing five (5) .38 special cartridges, fourteen (14) small glassine bags containing suspected Crack-cocaine, Marijuana in a quantity estimated to be less than fifty grams, CDS Paraphernalia and \$453 dollars in United States Currency. Louis Tiller was arrested and transported to Police Headquarters for processing. Bethany Kerr was processed accordingly and released. Louis Tiller was processed and remanded to the Camden County Correctional Facility in default of bail
