The Pine Hill Police Department conducted multiple warrant arrests in the 200 Block of West Branch Avenue between the hours of 6:00AM and 9:00AM on Saturday, January 19, 2013. The warrant arrests were part of an effort to assist in the investigations of several robberies in the area and narcotics distribution.
