INCIDENT:	Possession Crack Cocaine, Heroin and Marijuana with intent to Distribute w/in 500ft of a Park	DATE/TIME:	01/17/2013 9:11PM

On January 17th, 2013 at approximately 9:11PM, Pine Hill Officers conducted a motor vehicle stop on West Branch Ave in the area of the Steven Wilz Playground for an equipment violation. During the course of the motor vehicle stop the operator, identified as Dwight Robinson and the passenger, identified as Sarah Marley were arrested on active warrants out of Camden City. Continued investigation by Officers at the scene led to a K-9 narcotics sniff of the vehicle, which resulted in a positive alert for the presence of a narcotics odor coming from the vehicle. A search warrant was obtained on the vehicle which led to the discovery of a hidden compartment in the dashboard. Over half-ounce of crack cocaine packaged in 49 bags, 6 bags of heroin, 15 grams of marijuana marked "Lambs Breath", and CDS paraphernalia seized along with more than \$1200.00 in United States Currency. Both subjects were processed accordingly and remanded to the Camden County Correctional Facility in default of bail.
