On January 11, 2013 at approximately 1207 hours Pine Hill Officers were dispatched to the 3700 block of Community Circle West (Tall Pines Development) for the report of a home invasion type robbery. The victim reported he and his 3 year old daughter were inside of their home when two unidentified males forced their way into his townhome, by kicking in the front door. One of the males was armed with a silver semi-automatic handgun. The males threatened to kill him and his daughter. The armed male forced the male victim to an upstairs bedroom with the handgun held against his head. While upstairs the two suspects ransacked the bedroom and stole several pieces of jewelry, a cellular telephone, and approximately \$480.00 in United States currency. The males then fled the area in a gold or brown colored Nissan.

At approximately 12:17PM Gloucester Township Police Officers stopped a vehicle matching the description on Jarvis Road by Pine Glenn Drive in Erial. The vehicle was occupied by two males, identified as Brandon Cooper and Davon Obryant-Still. Continued investigation at the scene of the stop led to the arrest of both males. Both suspects were processed accordingly on the below listed crimes and remanded to the Camden Correctional Facility. Anyone with information regarding this incident is asked to contact Det.
