<b>INCIDENT:</b>	Possession over 1lb of Marijuana w/ intent to Distribute - Possession of Handgun (x2) – Possession of Stolen Handgun (x1) – Endangering the Welfare of a Juvenile	<b>DATE/TIME:</b>	02.13.2013 3:55PM

On February 13, 2013 at 3:55PM Pine Hill Officers were dispatched to Building 48 of Chalet Gardens Apartments for the report of a fight involving several males. While en-route to the scene Officers were advised one of the males was reported to be armed with a handgun. While investigating the incident the Officers smelled a strong odor of raw Marijuana coming from the apartment where the incident had occurred. A female, identified as Dominique Dillard attempted to remove a bag from the apartment, indicating it contained items for her two year old child who was also present, but the Officers did not permit the bag to be removed from the scene. The scene was secured and a search warrant was obtained for the search of the residence. The following items were seized;

- Two handguns (one reported stolen out of Pennsylvania) recovered from the bag reported to have contained items for the child.
- Over 1lb of Marijuana
- CDS paraphernalia and packaging materials
- Shotgun ammunition
- Rifle ammunition

Dominique Dillard was also found to have Marijuana in her possession. Dominique Dillard and Adriess Moore, both residents of the apartment were charged accordingly and remanded to the Camden County Correctional Facility. Appropriate notifications were made regarding the safety of the child. All other individuals detained during the incident were released.
