On July 10th, 2013 between 2:00pm and 6:00pm the Pine Hill Police Department conducted a Directed Patrol in the area of Blackwood-Clementon Road and W. Branch Avenue. The Directed Patrol was a high visibility traffic enforcement detail. In addition to summonses being issued for unlicensed or suspended drivers and for operating a motor vehicle while in possession of CDS. Four individuals were arrested; one on outstanding warrants, three for narcotics offenses.

On July 19th, 2013 at approximately 08:30pm Pine Hill Police Officers were assigned to a Directed Bike Patrol in the 200 block of W. Branch Avenue. The Bike Patrol Officers conducted a motor vehicle stop after observing an individual in the Mansions Apartments complex in violation of a Drug Offender Restraining Order (DORO). During the stop the Officers observed the passenger, identified as Adam Cooper of Pine Hill with a quantity of suspected CDS clenched in his hand. Cooper resisted arrest, but was taken into custody without injury to the Officers. Further investigation determined the CDS to be over 2.5grms of Heroin. The driver of the vehicle, Alexis Koba was taken into custody and found to be in possession of Heroin and CDS Paraphernalia.
