On Thursday, June 13th, 2013 at approximately 9:26pm, Pine Hill Officers were assigned to a directed bicycle patrol in the Mason Run / Tall Pines communities. During the patrol the Bicycle Officers observed two occupied vehicles parked in a suspicious manner. The Officers observed a suspected narcotics transaction and initiated an investigation involving both two vehicles.

Investigation at the scene confirmed two males and a female were engaged in a narcotics transaction at the time the Officer approached to investigate the suspicious activity. Four bags of marijuana and CDS paraphernalia were seized. Also seized from one of the vehicles was a quantity of Marijuana hidden in a rolled up complaint-summons that had been issued to the female for a previous narcotics arrest in Pine Hill. The summons and Marijuana was located in the glove compartment of the vehicle.
