On Thursday, June 13th, 2013 at approximately 9:36pm, a Pine Hill Officer patrolling the area of the 200 block of Erial Road located two suspicious males alongside of a business. Investigation at the scene revealed the males were engaged in a suspected narcotics transaction at the time the Officer approached to investigate the suspicious activity. As a result, two packets of Heroin, three bags of Crack-Cocaine, one hypodermis needle, along with CDS paraphernalia were seized at the scene. Both males were taken into custody and remanded to the Camden County Correctional Facility in default of bail.
