On Friday, May 31<sup>st</sup> 2013 at 7:44pm a Pine Hill Officer assigned to a directed patrol in the Mansions Apartments (220 W. Branch Avenue) conducted a motor vehicle stop with an occupied, suspicious motor vehicle. During the investigation, a large quantity of narcotics were seized, including over 2.5 ounces of Marijuana packaged for distribution, 28 bags of Crack Cocaine and 26 packets of Heroin, along with a digital scale. All of the Four (4) adults and two (2) juveniles were arrested at the scene of the stop and charged with numerous narcotics offenses, including;

- Possession of a Schedule I Narcotic with intent to distribute
- Possession of s Schedule II Narcotic with intent to distribute
- Possession of over 2.5 ounces of Marijuana with intent to distribute
- Possession of CDS with intent to distribute within 500ft of the Mike Demarco Recreation Center
- Possession of CDS Paraphernalia
