INCIDENT:	Possession of Marijuana with Intent to Distribute	DATE/TIME:	March 22, 2013 9:26 PM

On Friday, March 22, 2013 at approximately 09:26pm Pine Hill Officers patrolling the area of Blackwood Road observed two suspicious occupied motor vehicles in front of the Main St. Deli, 300 Blackwood Road. The occupants of both vehicles were believed to be involved in suspected narcotics transaction. Both motor vehicles were stopped and investigation at the scene revealed that two females and one male were engaged in a suspected narcotics transaction at the time the Officer initially located the suspicious motor vehicles.

A search of one vehicle, occupied by Kathleen Devereaux and Heather L. Crawford led to the recovery of CDS Paraphernalia and over one ounce of Marijuana. A search warrant obtained for the second vehicle operated by Dawud Cooper. Subsequent search of the second vehicle led to the seizure of an additional quantity of Marijuana. Devereaux and Crawford were arrested at the time of the stop. Both were processed and released pending a scheduled court appearance. Cooper turned himself in at Police Headquarters on March 26th, 2013 at was remanded to the Camden County Correctional Facility in default of cash bail.
