INCIDENT:	Distribution of Over 4.5oz Marijuana within 1000ft Elementary School & 500ft Public Park	DATE/TIME:	03/09/2013 12:20AM

On Saturday, March 9, 2013 at approximately 12:20am a Pine Hill Officer patrolling the area of West Third Avenue and Erial Road located two suspicious males alongside of a closed business. Investigation at the scene revealed the males were engaged in a suspected narcotics transaction at the time the Officer approached to investigate the suspicious activity. Over 4.5 ounces of Marijuana and CDS paraphernalia were seized at the scene. The suspected narcotics transaction was being conducted within 1000ft of the Dr. Albert Bean Elementary School and 500ft of the W. 5th Avenue Community Park. Both males were taken into custody without incident, processed accordingly and remanded to the Camden County Correctional Facility in default of bail.
